



PARTICIPANT CHECKLIST & RTV POLICIES

we encourage you to read this document in its entirety as it contains important information regarding our policies and your purchase

REGISTRATION

You can register from the workshop main page or by clicking the link REGISTER on every page. You can also access registration from the DATES AND AVAILABILITY FlashFact Slide on any page of the workshop you are viewing. Registering for a workshop will automatically subscribe you to our E News Magazine and other NewsFlash we may send via Email.

PAYMENT

Payment is accepted through a secure server provided by Paypal.com. You can make your payment by using a major credit card, echeck or a Paypal account. You will receive an email confirming successful registration virtually immediately. If by next day you have not received a confirmation please let us know at info@renovance.tv. Should you require making a payment by check please contact us requesting so in an email to info@renovance.tv. Please note that if your check is not issued in the State of Connecticut our bank will require five business days to clear your check. Your registration and enrollment will be final only when your check clears or payment processing is completed.

CANCELLATION

Our intent is to always strive to make your experience at Renovance.tv a positive one, from the moment you visit our website, and onwards. It is a fact of life that sudden events may change the way we plan our schedule and we appreciate that. Our Reality Training Workshops are designed for a limited number of participants and can only run on a full enrollment due to the high production costs involved. Following is our cancellation policy:

- Up to 60 days before workshop start – 100% refund
- Between 30 and 60 days before workshop start – 50% credit towards another workshop
- From 30 days prior to workshop start your registration is final and no credit can be requested

REFUNDS

All refunds are made for the amount following the above policy less 5% processing fees. Refunds are made in the same payment form you used to enroll. Should you wish to request a refund simply send an email to info@renovance.tv

YOUR CONTACT INFO

Please note that the email address you use to register is the one we keep on record and utilize to communicate with you. If you wish to have messages sent to a different address you need to let us know. Similarly we ask you to check your inbox from time to time after your registration as we will be sending you information regarding the course. Also, after enrolling we recommend that you provide us with your phone contact where you can be reached prior to and during the workshop. A cell phone or hotel number are ok. It will be used solely to contact you should an urgent need arise. Again, please email us at elite@renovance.tv Anytime you provide us with any personal information including telephone numbers and email addresses we consider it highly confidential and we will not disclose it without your prior written permission. Renovance retains the right, at all times to modify or cancel dates in compliance with our Rollover Option described here below.

WORKSHOP CANCELLATION AND ROLLOVER OPTION

Workshop dates can be canceled at any time by Renovance for emergency reasons or because enrollment did not reach the minimum to secure the course. In case of a cancellation you will be immediately notified via email and offered three options.

- Receive a \$ 50 refund and rollover your registration to a different date
- Receive a \$ 50 refund and request a credit towards another workshop
- Receive a full refund within 90 days from the cancellation date – in this case there will be no processing fees deducted

Renovance is not responsible, under any circumstances, for any travel or hotel expense you may incur as a consequence of a cancellation. We strongly recommend you to check with us shortly before the workshop commencement to make sure the course is a go-ahead before you finalize your travel arrangements. We also recommend you to purchase travel insurance which will cover your costs in case of a cancellation. Such insurance is readily available on the Internet and it is not very expensive.

By enrolling in any of our workshops you specifically release Renovance from any and all liability issues arising from canceling or changing the date of a published workshop. We will make every reasonable attempt to communicate any changes to you utilizing the email you provided at enrollment and/or your telephone number if you have provided us with one. It is your responsibility to frequently check your email and to provide us with your contact phone number. In the event that it's impossible to reach you to inform you of a change or cancellation of a published date, you will only be offered the rollover option or a credit towards another workshop of equal or lesser value but you will not be entitled to a refund.

LIMITED PARTICIPATION & FILMING OF THE WORKSHOP

All our workshops are designed for a limited participation to comfortably fit everybody in the venue and guarantee a memorable experience. Please note that some of our workshops will be filmed and images may be used by Renovance in the future. By registering you agree to allow Renovance to use your image in perpetuity, should you appear in such filming of the workshop, in any form or manner including but not limiting

to promotion and advertising as well as part of other Training Programs in whatever format they may be delivered by RTV.

SKILL LEVEL REQUIRED TO REGISTER

For any RTV workshop you need to have a working knowledge of digital photography. This includes basic operations with a light meter and your memory cards. If a workshop has a particular skill requirement, it will be widely announced in the Course Description page on the website.

EQUIPMENT

If the workshop you have purchased requires you to bring equipment such as your camera, light meter or laptop, it will be announced in the Course Description page on the website. Any required studio equipment including sets, flash packs, heads and light modifiers will be provided by RTV. Please note that the Studios and/or Renovance are not responsible for any damage or loss of your equipment during the duration of the workshop. If you decide to leave your equipment in the studio overnight you are doing so at your own risk. Camcorders and tape recorders are not allowed in the studio at any time.

WHAT ARE YOUR RIGHTS TO USE YOUR IMAGES

During any workshop, including those where you shoot the models on set, you are prohibited to shoot any photograph or record video of any of the models. This includes all types of candid, real life or documentary style images. The same applies to any device capable of recording images or video and not exclusively to your own cameras. The only time you are allowed to shoot models is when they are on set during a workshop that includes participants shoot. In that case the following applies:

The following applies to workshops where participants will be shooting the models on set. You can use any and all of the images you have shot on set during the workshop ONLY for your personal use. This means any vehicle to promote and/or showcase your work.

Examples are your

- Portfolio
- Website
- Composite cards
- Mailers
- Promos
- Invites to exhibits
- Editorial stories published in print or online about yourself or your work

Within the scope of what explained above, you are not allowed to use any of the images in connection with any other material, either photographic or in any other form, which could be considered offensive, inappropriate or in any way or manner diminishing of the model's image or market positioning. This includes total nudes, glamour photography, buxom photography, soft porn or hard porn. If any of this type of photography is shown in connection with any image shot at any RTV workshop, RTV

reserves the right to request you to remove it. If by any chance you are in doubt, please contact us at elite@renovance.tv prior to publishing any image at risk.

AT ANY GIVEN TIME YOU ARE PROHIBITED TO USE ANY OF THE IMAGES YOU SHOT AT ANY RTV WORKSHOP FOR ANY PURPOSE WHICH INVOLVES A FINANCIAL TRANSACTION INCLUDING ANY FORM OF PAYMENT AND/OR BARTER, CHARITY, EXCHANGE. AS A RULE OF THUMB, YOU CANNOT RELEASE THE RIGHT OF USE IF ANYONE, EITHER YOU OR THE RECIPIENT OF THE IMAGE, IS MAKING ANY MONEY FROM THE IMAGE.

If you are prompted with such a situation contact us at elite@renovance.tv so that we can advise you on how to proceed. Any commercial exploitation of images shot during the workshop requires a fee negotiation with the Model's Agent or Representative and their written release. As RTV only works with top modeling agencies, please note that they are very well equipped to pursue any misuse of their models' image to the full extent of the law. RTV will not be held responsible in any case or form for your breach of this policy. In addition to agreeing to this policy, you, as the photographer, are **completely and personally responsible** for any legal issues related to the use of the images you shoot. Please note that by enrolling in any of RTV workshops you are agreeing to release Renovance from any and all liability issues arising from breaching this policy. You are also agreeing that, in case a liability issue may arise, you will take such a liability upon yourself as the creator of the image and agree to be the sole responsible party for any and all uses of such images and related fees to the modeling agency as well as all legal expenses and attorney's fees. In addition, please note that by signing this policy you hereby agree to not release, sell, donate or transfer in any form or manner, in whole or partially, your copyright on any images you shoot during the workshop. This also applies to entering photography contests that require such a transfer of copyright or/ and ownership of the image.

RTV RIGHT TO USE YOUR IMAGES

RTV reserves the right to use any of the images shot by any participant in any of its workshops to promote and advertise its business. Similarly RTV reserves the right to modify, retouch, post produce any of such images for the purpose of promoting and/or advertise its business as well as for delivery to the modeling agencies providing models for the workshops and to the creative crew (hair dresser, makeup artist, stylist).

RTV RIGHT TO REFUSE ENROLLMENT

In order to protect our contractual obligations with our Partner Companies as well as the Model Agencies we work with, Renovance retains at all times the right to refuse enrollment to any particular customer. In case we decide not to accept your enrollment you will be promptly refunded 100% of your payment and notified via email.

BEHAVIORAL STANDARDS DURING THE WORKSHOP

At any time during the workshop participants need to maintain a behavior that is respectful of other participants, models, creative crew, studio personnel and RTV personnel. Please carefully read this note regarding RTV models. Our models are Agency Models. This means they are represented by an Agent who is in charge and responsible for their business and career. For the participant this means that no business discussions, including arrangement for future shoot or test, should ever be discussed

directly with the model. Similarly personal information exchange or requests to meet outside the workshop is never allowed and will not be tolerated. In addition RTV requests all participants to have a decent clothing standard. If your look is not deemed appropriate RTV reserves the right to refuse you entrance to the workshop until you have modify it to comply. You are also requested to avoid any direct requests of any time to Studio personnel. As RTV is renting the studio any such requests should be directed solely to RTV personnel. If for any reason your behavior is not compliant with RTV standards, hereby defined, RTV reserves the right to ask you to leave the workshop. You agree that in this case you will be forfeiting your enrollment fees and no refund, nor any reimbursement for expenses can be requested to RTV, no exceptions made.

The PLATINUM BOOK™ Reality Training Workshop is limited to only 12 Photographers per event. We monitor registrations in real time during business hours Mon through Fri 9 am to 5 pm EST. During this time if a workshop is filled we immediately post it as CLOSED in the FLASHFACTS. As we have a large number of international customers which are on a different time zone, there may be a possibility that a class may get overbooked. Registrations are accepted based on the date and time you processed the payment. If your registration exceeds the limit we will promptly contact you and offer you the option to rollover to another date or receive a full refund.

At time of checking in for the workshop you will be requested to sign a copy of this policy. Refusal to do so will deny you access to the workshop and forfeit your enrollment fees.

RENOVANCE.TV TERMS, PRIVACY POLICY and DISCLAIMER

By accessing any areas of Renovance.tv or RTV ("Site" or "we"), you agree to be legally bound and to abide by the terms and conditions of this privacy policy as set forth herein ("Policy"). If you do not agree with this Policy, do not use this Site.
